Re: Freedom of Information Application

I am pleased to inform you that access is being provided to Documents 1-7 in the attached document list and copies of those records are attached.

In relation to Document 7, this provides an example of the records produced by the University's Laboratory Animal Services in purchasing feed for animals. I have been informed that these relationships are for commercial supply only and purchases are made at full price.

Following consultation with the company concerned, I have determined that access to Documents 8-9 is denied under Schedule 1 Clause 7 regarding documents affecting the business affairs of a third party and Clause 9 regarding documents containing confidential material.

The information within the contents of the emails and draft agreement contains identifying information which is of commercial value to and concerns the business and financial affairs of the company. The subject matter concerns a proposed arrangement which if provided to third parties would substantially damage the value of the arrangement.

The information within the documents is also in draft form and incomplete and was provided on the basis that it would remain confidential.

Under Sections 29 and 38 of the Freedom of Information Act, you may ask the Vice-Chancellor to review the decision not to disclose information that you requested. You have 30 days from the receipt of this notice to request a review by completing the attached application form.





YOUR RIGHTS TO REVIEW AND APPEAL

1. INTERNAL REVIEW

Under S.29 and S.38 of the Freedom of Information Act (SA), 1991, if you are dissatisfied or "aggrieved" with certain decisions or "determinations" of the University (regarding access to documents or amendment of records) you can apply for an internal review of its determination.

To apply for an internal review of a determination you must write a letter or lodge an internal review application form with the University. The application should be lodged within 30 days of the original determination.

There is no right to an internal review of a determination made by the Vice-Chancellor.

2. INVESTIGATION BY THE OMBUDSMAN

If, after an internal review has been completed, you are still dissatisfied with the University's determination you can request an investigation by the Ombudsman of the determination. The Ombudsman is empowered to investigate the conduct of any person or body in relation to a determination made by an agency/council under the Act.

An application under this section must be made within 30 days after notice of the review decision has been given.

Investigations by the Ombudsman are free. Further information is available from the Office of the Ombudsman.

3. APPEAL TO THE DISTRICT COURT

If you are dissatisfied with a determination by the University after internal review or after review by the Ombudsman, you can appeal to the District Court.

Applications must be made within 60 days after the relevant determination was given to you or, if you have sought an investigation by the Ombudsman, within 60 days after the results of the Ombudsman's investigation of the complaint were reported to you.

The procedures relating to applications to the District Court are established by the Court.
