RCVS Elections 2010 Manifesto

Biography

I graduated from the RVC [Royal Veterinary College, University of London] in 1972. Some fifteen years later I gained first inkling that most of my carnivore patients were suffering diet-induced diseases. Careful investigation revealed that the veterinary profession, colluding with pet-food makers and so-called animal welfare groups, had falsified the records regarding preventable diseases and premature death affecting millions of pets. (Harold Shipman hid in plain sight behind falsified records too!)

Despite establishment disbelief and denial, there is a scientifically sound solution understood by thousands of conscientious pet owners: *Raw meaty bones promote health*. In 1991, part blowing the whistle and part sharing a simple concept with profound health benefits, I published <u>Oral Disease in Cats and Dogs</u>.

In 1992 I delivered the Pandemic of Periodontal Disease lecture, chaired by Richard leCouteur (now

professor at UC Davis) and attended by six academic vets including <u>Professor David Church</u> and <u>Dr Jill Maddison</u> (now of RVC). Dr Richard Malik attended and has since made significant <u>contributions</u>. Otherwise the information was treated with contempt by an arrogant assembly.

If the vet establishment refused to act, then I would. Since 1992 I have worked to solve the gravest issue facing pet health and the veterinary profession in the 21st century.

Manifesto

From the outset a corrupt veterinary establishment fought back. I was subjected to several bogus disciplinary actions and threatened with jail. To avoid harassment and find time to write, I sold the practice in 1997 and in 2001 published *Raw Meaty Bones: Promote Health*.

During the election period the book can be downloaded for free at www.vetsurgeon.org. Please read the book and consider the range of options available for reforming our sick profession.

Clearly our veterinary educational institutions, political structures and representatives have not helped; in fact theyve done untold harm. We need a wide-ranging enquiry leading to the creation of a new Veterinary Surgeons Act. The prostitution of our profession must stop, a scientific renaissance could follow. Institutions and individuals should be held accountable. Veterinary students deserve a better deal. We can launch law suits against veterinary schools that perpetuate false and misleading information in support of their junk pet-food sponsors. http://www.rawmeatybones.com/campaign/legal-vet.php

Junk pet-food companies have infiltrated the highest levels of our profession. A chief scientist for Mars and a sales manager for Hills are past presidents of the RCVS. Another past president is in receipt of junk pet-food largesse and a councillor coordinates the Pet Smile scam. Twelve councillors represent the vet schools all in receipt of junk pet-food hush-money.

On a community level we can hold client information evenings and generally encourage discussion and understanding. Roger Meacock and I are available to address student groups, university faculties and professional meetings.

In our daily work we can practise what we preach: Ensure the welfare of the animals committed to our care.

Please use your vote strategically. Vote only for those who can be relied on to deal with the gravest issue facing our profession in the 21st century. Thank you.

Thank you for your email.

I am not a veterinarian, though I sit on RCVS Council and Head the Cambridge Veterinary School. I therefore have a somewhat detached lay person's view of the veterinary profession and many of the scientific issues underpinning it. I am a microbiologist and have published nearly 200 papers in peer-reviewed journals, books etc. I Chair the RCVS Research Sub-Committee. I am also a member of the General Advisory Committee on Science at the UK Food Standards Agency. I therefore think that I am justified in considering myself a scientist with a high international reputation, though animal nutrition is clearly not one of my strengths!

I am very disturbed by your comments about corruption in the veterinary profession. I have worked in the pharmaceutical industry, in small biotechs, and in various University Departments, including the Institute of Molecular Medicine at Oxford, so I have a broad experience of scientists, medics and vets. There are always black sheep in any profession, but in my experience the veterinary profession is populated by honest people who are most definitely not corrupt. I consider your comments about the veterinary profession being corrupt as being highly defamatory, unworthy, and of course counterproductive to your cause if you really are interested in promoting your view of what pet animals should be eating.

Your conspiracy theory that money given by industry corrupts education at the UK veterinary schools is simply completely and utterly wrong-headed. I can only speak for Cambridge, but the idea that an institution as venerable as this one, with its tradition of complete academic freedom, could be bought off for a few quid given by a pet food company is fantasy and frankly insulting.

You will note that my Chair is endowed by Marks and Spencer, so I have some direct experience of this kind of conspiracy theory thinking. I am someone who values my academic freedom above all else, actually. I made this point when I was appointed to this Chair, and I have never shied away from being critical of the retail food industry when necessary. Indeed I wrote a letter to the Guardian newspaper not so long ago, in response to a mud-slinging article that they had published, making it clear that it was insulting and wrong-headed to assume that just because something is endowed by a commercial company then being supported by that endowment means that the incumbent is somehow in thrall to the endower.

I am not very well up to speed with the science under-pinning the view that raw meaty bones are better for pets to eat than commercial pet food. What I have seen is unconvincing. I am also intrigued that pet animals are living longer than ever before, with higher quality of life, and I do not understand how this can be the case if commercial pet food is as bad for the animals as you suggest. I am sure that you will have confronted this argument, and I look forward to hearing your refutation.
