Let's take another look at the Royal College of Veterinary Surgeons, eighteen years after they were first informed of the mass poisoning of pets and the mass deception of pet owners.

## **Rotten Callous Venal Sham (RCVS)**

Chances are that if you keep a pet you've been on the receiving end of the rotten, callous, venal sham that passes for veterinary care. Instead of the vet recommending a healthful, life-saving natural diet you will likely have been cornered and coerced into a guilt trip. You will have been browbeaten and nigh on ordered to feed your pet the packaged junk on the vet's shelves.

Professor Sandra Scarr comments. 'Some vets are quite crazed ... so blinded by pet food dogma, they can't practise medicine responsibly.' Others tell of ranting, apoplectic vets screaming about imagined bacterial diseases and blocked intestines. They speak about the same vets milking them of thousands of dollars pursuing worthless tests, prescribing dangerous medicines and still no solution for their pet's chronic ailments. But fortuitously, by searching the internet, the pet owners tell how they discovered the benefits of a raw meaty bones diet and the dog, otherwise condemned to a slow death, turns a corner and becomes like a puppy again.

Unfortunately the junk food problem runs as part of the narrative at all levels of the vet profession in all countries of the world. Although it's true that some veterinary regulatory bodies and some veterinary associations have not yet been confronted over their disgraceful activities. (Hint to those in America, start badgering the State Veterinary Boards now.) Whilst ignorance is no defence, they can purport to be unaware of the depravity of their crimes.

In the UK, the Royal College of Vet Surgeons, governing body of the vet profession overseeing some 21,000 registered vets cannot plead ignorance. In the early days my esteemed College lecturers, the late Oliver Graham-Jones FRCVS (longtime RCVS Councillor) and Arthur Hayward MRCVS, provided nominations and testimonials. More recently Bill Miller, Roger Meacock and Alan Bennet have lent their support.

Each year about 10% of voters support the campaign. That's around 350 vets who by voting for rmb register a complaint of massive malfeasance against the veterinary authorities — a complaint that the RCVS actively or passively condones the mass poisoning of pets, dupes pet owners and veterinary students throughout the UK.

Here's the 500 word RCVS election statement for this year:

### **Biography**

I graduated from the RVC [University of London] in 1972. Some fifteen years later I gained first inkling that most of my carnivore patients were suffering diet-induced diseases. Careful investigation revealed that the veterinary profession, colluding with pet-food makers and so-called animal welfare groups, had falsified the records

regarding preventable diseases and premature death affecting millions of pets. ([Harold Shipman](#) [notorious medical practitioner and mass murderer] hid in plain sight behind falsified records too!)

Despite establishment disbelief and denial, there is a scientifically sound solution understood by thousands of conscientious pet owners: Raw meaty bones promote health. In 1991, part blowing the whistle and part sharing a simple concept with profound health benefits, I published [Oral Disease in Cats and Dogs](#).

In 1992 I delivered the [Pandemic of Periodontal Disease](#) lecture, chaired by [Richard leCouteur](#) (now professor at UC Davis) <http://faculty.vetmed.ucdavis.edu/faculty/ralecouteur/> and attended by six academic vets including [Professor David Church](#) and [Dr Jill Maddison](#) (now of RVC). Dr Richard Malik attended and has since made significant [contributions](#). Otherwise the information was treated with contempt by an arrogant assembly.

If the vet establishment refused to act, then I would. Since 1992 I have worked to solve the gravest issue facing pet health and the veterinary profession in the 21st century.

### **Manifesto**

From the outset a corrupt veterinary establishment fought back. I was subjected to several bogus disciplinary actions and threatened with jail. To avoid harassment and find time to write, I sold the practice in 1997 and in 2001 published *Raw Meaty Bones: Promote Health*.

Clearly our veterinary 'educational' institutions, political structures and representatives have not helped; in fact they've done untold harm. We need a wide-ranging enquiry leading to the creation of a new Veterinary Surgeons Act. The prostitution of our profession must stop, a scientific renaissance could follow. Institutions and individuals should be held accountable. Veterinary students deserve a better deal. We can launch law suits against veterinary schools that perpetuate false and misleading information in support of their junk pet-food sponsors.

In our daily work we can practise what we preach: [Ensure the welfare of the animals committed to our care.](#)

Please use your vote strategically. Vote only for those who can be relied on to deal with the gravest issue facing our profession in the 21st century. Thank you.’

So imagine the trauma in the UK when it was discovered that medical doctor Harold Shipman had murdered 250 and possibly more of his elderly patients. Shipman's killing spree led to the establishment of a major enquiry costing the UK Government £21 million and resulting in a major shakeup in the medical profession.

Shipman hanged himself in Wakefield Prison in 2004. Nowadays his ghost surely hovers over the UK medical profession as it seeks to guard against future such atrocities.

I mentioned Shipman in the RCVS Election manifesto (above) for one very important reason. Shipman killed 250 of his patients. For vets, the mass killing of their patients, numbering in the thousands, is a regular part of the job. And I'm not talking about the euthanasia of pets nor the humane destruction of farm animals. No, I'm referring to the disease and death most vets mete out to their small animal patients as a matter of course.

By steadfastly insisting that pets be fed junk food, vets either know or should know that they are killing their patients. They bluff, they bluster and seek to deny the obvious. But it's increasingly clear to anyone with an ounce of common sense that a majority of vets are hiding behind transparent lies.

So let's invoke the Ghost of Harold Shipman, let's lobby political leaders the world over to set up commissions of enquiry into the corrupt, death delivering vet profession. Please send this newsletter and any supporting information to your political representatives, to your local newspapers, radio and television and demand that the widespread maiming and killing of pets by vets be stopped.
