A majority of vets, when speaking about pet carnivore diets, say industrial food from the factory is GOOD: nature's version, based on raw meaty bones, is BAD.

Any sane person knows that's upside down, back to front nonsense, made the more so since it's the collective view of so-called trained healthcare professionals. Why do the world's vets promote the bad and resist the good?

Could it be that vets and their institutions are tied up with the junk pet-food factory owners, indeed the whole junk pet-food industry? British Small Animal Veterinary Association (BSAVA) Dog Food Study

As the name suggests the British Small Animal Veterinary Association is the small animal division of the British Veterinary Association. They have a long history of conspiring with the junk pet-food industry. Under the banner of Petsavers <u>http://www.petsavers.org.uk/</u> the BSAVA produces publications and fronts 'research'. 'Growing kittens have specific nutritional requirements, and the simplest

way to fulfil them is to buy a good quality complete diet from a reputable manufacturer. For the first few days after your kitten comes home, continue to feed the food she's used to, to help prevent tummy upsets. Then you can gradually introduce a new food. Moist or dry? It's up to you. However dried foods are more convenient to feed and help to keep your cat's teeth free from a build up of tartar which can quickly lead to dental decay.' (end quote)

Of course anyone with a modicum of knowledge knows that dental tartar is associated with rotten gums, not dental decay. But then the BSAVA has not been too concerned about either accuracy or empathy for their victims. See their 'pull'em out and chuck'em away' indifference to cats' teeth when they say in their junk pet-food promotional booklet Scamps Diary: (quote)

'Don't worry if your vet says one or more of your cat's teeth need to be removed. Cats' gums are hard and tough, and even a toothless cat can eat crunchy dry food'. (end quote)

Lest there be any doubt, similar misleading and false information is promulgated by these BSAVA 'experts' for puppies too: <u>http://www.bsava.com/LinkClick.aspx?fileticket=ZxlLsfjh%2bhc%3d&tabid=153</u> (quote)

'Dog foods are broadly divided into two kinds dry and moist. Provided that you get the correct food for his age, the choice of the food for your puppy is down to you and your pet.' (end quote)

BVA, BSAVA, PFMA — it's as if they are interlocked and interchangeable. Have a look at their policy brief condemning raw meaty bones: <u>http://www.rawmeatybones.com/pol-brief.html</u>

Seeing their open hostility to raw meaty bones, it should come as no surprise that the BSAVA Pesavers are funding a researcher at Glasgow Veterinary School, Emily Courcier MRCVS, Resident in Small Animal Evidence Based Medicine <courcier@vet.gla.ac.uk>, to investigate the bacteria found in excrement from dogs fed a raw meaty bones diet.

If you've got a spare moment you might like to ask Ms Courcier what she knows about 'evidence based medicine' and why this interest in the excrement of raw meaty bones fed dogs? Do they wish to raise a stink about bacteria in dog poo in an attempt to distract from the disgusting stench of veterinary corruption.

## Royal College of Veterinary Surgeons Elections 2009

Thanks for the opportunity to comment.

In my view, the RCVS Council forum was most definitely an improvement on previous years. Hustings ought to be a fundamental part of any democratic election process -- free from interference by the establishment and the moderators.

As can be seen from the debate or absence of debate on vetsurgeon.org and the RMB Newsletter links (above) that the profession at large and the candidates are woefully ignorant of the issues. (Some are arguably incompetent and corrupt.)

As part of my 18 year long brief, I attempted to place information on the

record -- that being the least I could do in a hostile, uncomprehending environment.

As you know I stood on a platform recommending legal action against veterinary and pet food authorities. I believe that taking elements of my manifesto together with the discussions on vetsurgeon.org we can safely assume that the veterinary authorities have been put on notice. It may take time before these issues are finally actioned through the courts, however it will not be possible to deny the historical record. http://www.rawmeatybones.com/RCVS/RCVS2009.php

Whether the courts use this information to arrive at their verdicts and whether this information assists the courts in arriving at penalties remains to be seen.

For my part, although the election forum was time consuming and taxing, I am grateful for the opportunity to serve the profession and the wider community.

Next year, I hope that you will continue this forum. Improvements could be made whereby all 40 existing councillors as well as the candidates could be encouraged to attend.

In the meantime, I trust that the RCVS Council will take note that 389 veterinary surgeons effectively lodged a complaint about massive corruption within our profession; that the RCVS is itself heavily implicated and that the RCVS should take urgent steps to resolve the issues.
